Background:

The establishment of the full freedom of movement for workers between Bulgaria, Romania and the EU in late 2013 as well as the strong increase in applications for asylum from citizens of Kosovo, Albania and other western Balkan states in 2015, have recently moved Southeast Europe (SEE) into the focus of public attention. After all, the region has always been a traditional source of labour migration to Western Europe. Which are the dimensions and what are the reasons for the out-migration from SEE? What are the consequences of labour mobility for the societies in the region, not only concerning the loss of human capital but also in view of the potential development effects? What are the opportunities and challenges for the Western European labour markets and societies that occur as a result of the immigration? What (new) legal regulations exist in Germany for example in order to integrate immigrants from SEE into the labour market? What measures do governments, business associations and enterprises take in order to qualify and integrate workers both within their countries of origin and in their countries of destination?

Experts and responsible actors from enterprises, business associations, from the European Parliament, the European Commission, from the German Bundestag and from federal authorities, from universities and initiatives, are going to discuss the above mentioned questions and will try to formulate recommendations for adequate actions to be taken by the relevant actors.
